	<p>Solar PV</p>	<p>Includes roof, ground mounted system or a Community Solar Garden subscription (<i>must purchase capacity to meet at least meet 50% of existing household electricity consumption</i>) Installation by NABCEP certified installer only</p>
	<p>Ground Source Heat Pump</p>	<p>5.5 tons or smaller, must be ENERGY STAR</p>


	<p>Non-Cold Climate Rated ENERGY STAR Air Source Ductless Heat Pump</p>	<p>HSPF \geq9/EER \geq12.5/SEER \geq16 <i>Maximum rebate amount per home</i></p>
	<p>ENERGY STAR Ducted Unitary Heat Pump</p>	<p>HSPF \geq8.5 /EER \geq12/SEER \geq 15</p>
	<p>Attic Insulation with Air Sealing</p>	<p>R-49 minimum required in open attic; cathedral ceilings will vary with rafter depth but must meet requirements of 2012 IECC. Must perform air sealing in attics prior to adding insulation.</p>
	<p>Wall Insulation</p>	<p>R-19 minimum; fill wall cavity where R-19 not possible. For solid walls such as brick or concrete, exterior rigid insulation must be added to a level of \geq R-10.</p>

ENERGY STAR Electric Heat Pump Water Heater	Must be Energy Star certified with a minimum Energy Factor of 2.0
 Foundation (Basement or Crawl Space) Insulation and Air Sealing	Crawlspace as outlined in the 2012 IECC. R-15 continuous or R-19 cavity insulation with a vapor-permeable air barrier over insulation. Crawlspace must have sealed vapor barrier over dirt crawl space floor and ventilation, per 2012 IECC.

Solar Thermal Space Heating	For use with hydronic (boiler) systems, 20kW max. size, SRCC rated
 Whole House Evaporative Cooler	Permanent installations only; temporary or portable units are not eligible
Duct Insulation	R-8 minimum, in unconditioned space only.
Pellet Stove or High Efficiency Woodstove	Must be EPA certified; at least 72% efficient (wood) or 78% efficient (pellet). Only upgrades to a more efficient model; no new installations unless home uses electric heat.

 Whole House Fan	Fan must have an automated, insulated air sealing mechanism that engages when the fan is off (i.e., doors or damper mechanism, etc.). Must have controls (thermostat or timer, multi-speed).

Furnace Tune-Up	<u>For New EnergySmart participants only enrolling after 1/1/2020.</u> Tune-Ups must include cleaning (inc. filter) and lubrication, with checks on electrical, motors, ignition, thermostat, venting and testing combustion. A detailed invoice is required.

Lafayette Home Energy Assessment Discount
(no EnergySmart rebate applied)

\$75 off on an EnergySmart Home Assessment (regularly \$185) after undertaking through EnergySmart, an eligible energy efficiency or renewable energy improvement with a value between \$1,000 - \$4,999*

\$150 off on an EnergySmart Home Assessment (regularly \$185) after undertaking through EnergySmart, an eligible energy efficiency or renewable energy improvement with a value greater than \$5,000*

Conditions

- Rebates are only available to **EnergySmart participants** and for the measures listed. Enrollment in EnergySmart must occur **before** purchasing an appliance or completing the energy efficiency project for which a rebate is being applied for.
- Lafayette Bonus rebates are only available to households within the municipal boundaries of the City of Lafayette (Colorado) who are enrolled in EnergySmart and meet all other listed conditions and requirements.
- **EnergySmart and City of Lafayette funded rebates are limited, are subject to change, and will be awarded on a first-come, first-served basis.**
- Rebate amounts will be calculated based on current EnergySmart rebate levels when that eligible energy efficiency or renewable energy project was completed and the EnergySmart rebate application was submitted to an energy advisor.
- All work must be completed and invoiced between **June 1, 2020 and July 31, 2020** to qualify for these rebates.
- Total lifetime **maximum** of all **EnergySmart** rebates cannot exceed **\$1,800/home** and **\$6,000/owner** of multiple properties (inc past and present EnergySmart rebates). Exception allowed if due to the Solar PV bonus.
- Multi-Family Units of 5 or more are not eligible for this rebate.
- Rebates cannot exceed the cost of the measure after all other rebates are applied.
- All upgrades must be for or directly benefit unit occupants. (e.g. Only upper units can receive an attic insulation rebate when applying for multiple unit rebates.
- **All work unless noted, must be completed by a contractor participating in EnergySmart's Contractor Partnership Program.**
- All work must meet all applicable building or energy codes, and all required permits must be obtained. Combustion Appliance Zone (CAZ) testing must occur as a health/safety measure before and after the upgrade depending on the type of upgrade. *Please feel free to speak with your Advisor about the importance of CAZ testing.*
- * The EnergySmart Home Energy Assessment discount will be applied as a rebate added to the calculated energy efficiency or renewable energy rebate amount once all project documentation has been submitted to EnergySmart.
- **Summer Cooling Bonus rebates** apply to heat pumps for space cooling and heating, insulation projects with air sealing, whole house fans, and evaporative space cooling appliances only.
